## **PRIVACY POLICY**

- a) The Participant is informed that Legislative Decree no. 196 dated 30 June 2003 ( “Code regarding the protection of personal data”) provides for the protection of persons and other subjects regarding the processing of personal data. Under this decree, the processing carried out in relation to the entirety of the requested or requestable reports and services of Scuola Holden will be characterised by correctness, lawfulness and transparency and protection of the Participant’s privacy and other rights.
- b) Under Article 13 of Legislative Decree no. 196/2003, the following information is provided: in accordance with art. 13 of Legislative Decree no. 196/03, the personal and sensitive data contained in this enrolment form and in all other possible forms filled out by the Participant, will be used mainly by Holden S.r.l. for the administrative and accounting purposes of Scuola Holden, as well as the consent of the Participant to promote the Scuola Holden programmes. The data will be processed for the entire duration of the contractual relationship established and also subsequently, for the completion of all legal obligations.

The interested party has the right to be informed: a) of the personal data’s origins; b) of the processing purposes and methods; c) of the logic applied to the processing if it is carried out with the help of electronic means; d) of the identification data concerning the data controller, data processors and the designated representative as per art. 5 paragraph 2; e) of the

entities or entity categories to whom the personal data may be communicated or who may become aware of said data in their capacity as designated representative(s) in the State's territory, data processor(s) or person(s) in charge of the processing. 3. The interested party has the right to obtain: a) updating, rectification or, where interested therein, integration of the data; b) cancellation, anonymisation or blocking of data that have been processed unlawfully, including data whose retention is unnecessary for the purposes for which they have been collected or subsequently processed; c) certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected. 4. The interested party has the right to object, in whole or in part: a) on legitimate grounds, to the processing of personal data concerning him/her, even though they are relevant to the purpose of the collection; b) to the processing of data concerning him/her, where it is carried out for the sending of advertising materials or direct selling or for the performance of market or commercial communication surveys by contacting the owner of the data treatment: Holden S.r.l.
